FAQ

Q: What is the minimum investment required to obtain the Greek Golden Visa?

A: The minimum investment required to qualify for the Greek Golden Visa is €250,000. This investment can be made in real estate for commercial buildings converted into residential, located anywhere in Greece. This initial amount is the starting point for eligibility under the Golden Visa Program. Alternative higher ticket investment options are also available.

Q: What is the duration of the residence permit?

A: The duration of the residence permit granted through the Greek Golden Visa Program is renewed indefinitely for five year intervals, as long as the investment and other requirements are maintained.

Q: Can members of my family request a residence permit, and who is considered a family member in this context?

A: Yes, family members can request a residence permit through the Greek Golden Visa Program. Family members include the main applicant's spouse, children under 21, and financially dependent children. Additionally, parents of both the main applicant and their spouse can also apply.

Q: In which locations within Greece can I buy properties eligible for the Greek Golden Visa?

A: Properties eligible for the Greek Golden Visa can be purchased in various locations throughout Greece. There are no specific location restrictions, allowing investors to choose properties based on their preferences and investment goals.

Q: Can I rent the property I purchased?

A: Yes, you can. The Greek Golden Visa Program allows investors to rent out the property, following the law provisions.

Q: What is the duration for acquiring the Greek Golden Visa?

A: The duration for acquiring the Greek Golden Visa is quick. Once all the necessary documentation is in order and the application is processed, investors can typically obtain their residence permit in less than six months.
